MOTION FOR CORRECTION OF APPENDICES <u>TO JUNE 30, 2004 ORDER</u>

Kentucky Utilities Company ("KU") moves the Kentucky Public Service Commission ("Commission") to enter an order correcting certain information contained in Appendix A to the Commission's Order of June 30, 2004.

As grounds for its motion, KU states that on June 30, 2004 the Commission entered an order in this case deciding the issues raised in connection with KU's Application for approval of an increase in its electric rates. In Appendix A to that Order, the Commission set forth the approved rates and charges for KU's electric service rendered on and after July 1, 2004. Appendix A contains some incorrect or incomplete information. KU requests the Commission to enter an Order correcting the rates and charges contained in Appendix A as follows:

KU Electric Service Rates

None of the minimum charges were included in Appendix A to the Commission's June 30, 2004 Order. The minimum charges are a function of the rates for each schedule. The correct minimum charges are as follows:

On page 8, the charges for Rate CSR 3 should be expressed in kVA, rather than kW, since the rider is restricted to customers served under Rate LI-TOD, which contains charges express in kVA.

WHEREFORE, Kentucky Utilities Company respectfully requests that the Commission enter an Order revising Appendix A to the Commission's Order of June 30, 2004 as detailed above.
