The Defendant, B.T.U. Gas Company, Inc. files the following response to the Commission order of April 6, 2004.

RESPONSE TO REQUEST NUMBER ONE

1. B.T.U. has filed a map of its gas gathering system labeled B.T.U. Gas Company, Inc. Pipeline System dated December 11, 2000. In addition, B.T.U. files the attached map of the Salyersville area showing the gas mains and service connections for Salyersville.

The section of pipeline labeled A is 1500 foot of 3 inch SDR11 plastic pipe. The total cost was \$2,205.00 and the construction was completed in November of 2003.

The section labeled B is 200 foot of 2 inch plastic pipe. The total cost was \$200.00 and the construction was completed in September of 2003.

The section labeled C is 500 foot of 1 inch SDR11 plastic pipe. The total cost was \$385.00 and the construction was completed in 2001.

The section labeled D begins at the Mountain Parkway, though the Dixie area to Ivy Point Hill. This is approximately 8,000 foot of 3 inch SDR11 at a total cost of \$15,200.00. This construction was completed in 1992.
