**JOINT MOTION TO ESTABLISH SCHEDULE FOR
POLE ATTACHMENT TARIFFS**

JACKSON PURCHASE ENERGY CORPORATION

Come Jackson Purchase Energy Corporation (“JPEC”) and Ballard Rural Telephone Cooperative Corporation (“Ballard Rural”), by and through their respective counsel, and hereby jointly move the Public Service Commission to enter an order establishing a schedule for the filing and establishment of the pole attachment tariffs required by the Commission’s Order dated August 2, 2007 and to establish an effective date for the parties’ respective tariffs. As grounds therefore, the parties hereby state as follows:

JPEC had previously filed a Motion for Extension of Time requesting that it be allowed up to and including November 9, 2007, to file its pole attachment tariff. The basis for that motion was that JPEC believed it would need the additional time to update the numbers contained in its CATV tariff, which will serve as the basis for the tariff required by the Commission’s Order dated August 2, 2007. As the result of an informal telephonic conference with PSC staff on September 18, 2007, the parties now understand that in order to comply with the Commission’s Order dated August 2, 2007, they may not update any of the numbers contained in their respective CATV tariffs. As a result of that telephonic conference, Ballard Rural filed a motion to withdraw its pole attachment tariff. The Commission issued an order on September 24, 2007, requiring Ballard Rural to file its revised tariff no later than October 14, 2007. JPEC hereby respectfully requests, and Ballard Rural states that it has no objection, the


Commission establish October 14, 2007, as the date by which JPEC must file its pole attachment tariff also.

Further, the parties hereby request the Commission enter an order establishing January 1, 2008, as the effective date of both JPEC's and Ballard Rural's pole attachment tariffs. As grounds therefore, the parties state that the billing for 2007 has already been completed. Accordingly, it would be simpler for both parties if the Commission established January 1, 2008, as the effective date of both parties' pole attachment tariffs.

Now, therefore, the parties hereby jointly request that the Commission enter an order establishing October 14, 2007, as the deadline for JPEC to file its pole attachment tariff and establishing January 1, 2008, as the effective date for JPEC's and Ballard Rural's respective pole attachment tariffs.

The undersigned has received the permission and agreement of Counsel for Ballard Rural to file this joint motion.


