RESPONSE TO OBJECTION FOR MEDIATION

Comes the defendant, Jackson Purchase Energy Corporation ("JPEC"), through counsel, and for its reply to Ballard Rural Telephone Cooperative Corporation's objection to Jackson Purchase Energy Corporation's Motion for Mediation, states as follows:.

- 1. In its order dated March 23, 2005, this Commission clearly suggested that the parties attempt to negotiate a settlement of this matter.
- 2. Plaintiff's Response to JPEC's Motion for Mediation is a clear rejection of the Commission's suggestion.
- 3. JPEC believes that mediation in this matter might save the parties and, thereby, the rate payers money. Further, JPEC believes that allowing the parties an opportunity to discuss the matter face-to-face could lead to a reasonable conclusion for all parties involved.
- 4. Further, JPEC believes that a good-faith settlement discussion between the parties could resolve the impasse which exists in case number 2004-00319, styled *Application of*

Jackson Purchase Energy Corporation for Adjustment in Existing Cable Television Attachment Tariff.

WHEREFORE, JPEC respectfully requests that the commission make clear its desire that the parties attempt to settle this matter without the necessity of a hearing before the Commission by entering an order requiring mediation between the parties.
