**JACKSON PURCHASE ENERGY CORPORATION'S
RESPONSE TO MOTION TO SCHEDULE HEARING**

Comes the defendant, Jackson Purchase Energy Corporation ("JPEC"), through counsel, and for its response to Ballard Rural Telephone Cooperative Corporation Inc.'s ("BRTC") Motion to Schedule Hearing, states as follows:

As there is currently a Motion for Summary Judgment pending before the Commission, BRTC's motion is not appropriate for consideration at this time. Put simply, scheduling such a hearing is premature unless and until the Commission makes a decision on BRTC's Motion for Summary Judgment. If the Motion for Summary Judgment is granted, further hearings will presumably be completely unnecessary and it, therefore, seems better to schedule further hearings only after BRTC's Motion for Summary Judgment is denied.

WHEREFORE, JPEC respectfully requests that the Motion to Schedule Hearing be denied pending a ruling on BRTC's Motion for Summary Judgment.
