

ORDER

On May 27, 2004, Adair County Water District ("Adair District") applied to the Commission for a Certificate of Public Convenience and Necessity to construct the second phase of a \$3,296,000 waterworks improvement project, a rate adjustment, and approval of its proposed plan of financing. In Case No. 2003-00364,¹ this Commission issued a Certificate of Public Convenience and Necessity for the construction of the first phase of the proposed waterworks improvement project and for the water district's proposed plan of financing. Adair District now proposes revisions to the original plan of financing.

The second phase of the improvement project consists of the installation of approximately 22.5 miles of 8-inch through 3-inch water transmission mains and related appurtenances to provide service to approximately 113 new customers. Estimated total funds budgeted for completion of this project are approximately \$1.87 million. Adair District intends to enter into a contract with United Pipeline, Inc. to construct the proposed second phase improvements at a cost of \$844,385, and Adair District has budgeted \$1,025,615 for legal, engineering and other fees and contingencies.

Adair District proposes to fund both phases of the improvement project with the issuance of \$1,238,000 in water district revenue bonds to Rural Development² ("RD"), a \$900,000 grant from RD, a \$745,000 State of Kentucky 2020 Program grant, and a \$413,000 State of Kentucky Tobacco Settlement grant.³ Adair District further proposes to adjust its rates to ensure sufficient revenues to meet current operating and maintenance expenses, increase debt service costs, and meet expected increases in purchased water costs.

Adair District makes its application pursuant to KRS 278.023. This statute requires the Commission to accept agreements between water utilities and the U.S. Department of Agriculture or the U.S. Department of Housing and Urban Development and to issue the necessary orders to implement the terms of such agreements within 30 days of satisfactory completion of the minimum filing requirements. Given that minimum

Originally the total project cost was \$2,883,000. Adair District has revised the cost to \$3,296,000. Additional funding in the form of a \$413,000 grant from the Kentucky Tobacco Settlement Fund has been obtained. Adair District now proposes to adjust its rates.

filing requirements were met in the case on May 27, 2004, KRS 278.023 does not grant the Commission any discretionary authority to modify or reject any portion of this agreement.

IT IS THEREFORE ORDERED that:

1. Adair District is granted a Certificate of Public Convenience and Necessity for the second phase of the proposed waterworks improvement project as described in the Final Engineering Report appended to its application.
2. Adair District's proposed plan of financing, as amended in its current application, is approved.
3. Adair District is authorized to issue \$1,238,000 in revenue bonds to RD for the purposes set forth in its application in Case No. 2003-00364 and as amended in its application in this proceeding.
4. The proceeds from the revenue bond issuance shall be used only for the purposes specified in Adair District's application.
5. Notwithstanding Ordering Paragraph 4, if surplus funds remain after the approved construction has been completed, Adair District may use such surplus to construct additional plant facility if RD approves of the use and the additional construction will not result in a change in Adair District's rates for service. Adair District shall provide written notice of this additional construction in accordance with 807 KAR 5:069, Section 3.
6. Adair District shall file a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the

construction for which a Certificate of Public Convenience and Necessity has been issued.

7. The rates set out in Appendix A are the rates approved for water service that Adair District renders on and after the date of this Order.

8. Within 30 days of the date of this Order, Adair District shall file with the Commission revised tariff sheets setting out the rates approved herein.

9. Adair District shall notify the Commission prior to performing any additional construction not expressly authorized by this Order.

10. Adair District shall notify the Commission one week prior to the actual start of construction and at the 50 percent completion point.

11. Three years from the effective date of this Order, Adair District shall file an income statement, along with any pro forma adjustments, in sufficient detail to demonstrate that the rates approved herein are sufficient to meet its operating expenses and annual debt service requirements.

12. Ordering Paragraph 11 of this Order supersedes Ordering Paragraph 6 of the Commission's Order of November 10, 2003 in Case No. 2003-00364.

Nothing contained herein shall be deemed a warranty of the Commonwealth of Kentucky, or any agency thereof, of the financing herein accepted.
