**MOTION TO SUBMIT  
FOR EXPEDITED DECISION WITHOUT PUBLIC HEARING**

Crown Communication Inc. and BellSouth Personal Communications, LLC (hereinafter referred to collectively as "Applicant"), by counsel, and move the Kentucky Public Service Commission ("PSC") to grant a Certificate of Public Convenience and Necessity ("CPCN") in the within administrative proceeding forthwith based on the following facts and circumstances:

1. Applicant has met all filing requirements applicable to this proceeding as prescribed by the Kentucky Revised Statutes and the Kentucky Administrative Regulations, including notification of persons entitled to notice of the filing of the subject Application for CPCN by certified mail, publication and posted signs.

2. By its July 12, 2004 correspondence addressed to Mayor S. L. Mayolo, City of Wickliffe (copy filed with PSC on July 13, 2004), Applicant has responded directly to all correspondence filed to date in the within case.


3. To date and subsequent to all notification provided to potentially interested parties, no request for intervention has been filed with the PSC in this case.

4. The Application that is the subject of this administrative proceeding was originally filed with the PSC on June 25, 2004, and has been pending before the PSC for 25 days at the making of this Motion by Applicant.

5. The Wireless Communications Facility that is the subject of the Application for a CPCN filed in this case is a vital element of the Applicant's wireless communications network, and is necessary to provide service in accordance with the provisions of Applicant BellSouth Personal Communications, LLC's Federal Communications Commission license.

WHEREFORE, the Applicant, by counsel, urges the PSC to grant a CPCN forthwith in accordance with the terms of the Application in this proceeding and without public hearing.
