

BELLSOUTH'S MOTION TO EXPEDITE

BellSouth Telecommunications, Inc. ("BellSouth"), through its undersigned counsel, petitions the Kentucky Public Service Commission ("Commission") for expedited treatment of its Petition for Review of NXX Code Denial in the Louisville Rate Center filed August 2, 2004.

In support of its motion, BellSouth states as follows.

The request for an NXX code which NANPA denied is needed to meet the business needs of Citigroup in Louisville, Kentucky. The Citigroup Call Center represents a large investment in the state of Kentucky. Citigroup's business goal is to ensure its call center is operational before the end of the year. In order for Citigroup to meet its corporate objective, it plans to have the call center up and running in the next 30-60 days. BellSouth needs the additional numbering resources so that the Citigroup Call Center can be operational by that time.

For the foregoing reasons, BellSouth Telecommunications, Inc., respectfully requests the Commission to expedite its consideration of BellSouth's Petition for Review of NXX Code Denial in the Louisville Rate Center.


