



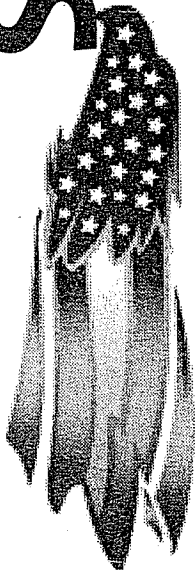
HEARING
