Dear Ms. O'Donnell:

The purpose of this letter is to respectfully request the Kentucky Public Service Commission (the "Commission") to refrain from ruling on the "Motion of BellSouth Mobility, LLC for Joinder of an Additional Party, Acceptance for filing of the attached Memorandum of Law, and for a Preliminary Procedural Schedule including an Informal Conference" in the above-referenced matter until East Kentucky Network, LLC ("East Kentucky Network") has had an opportunity to respond.

Counsel to East Kentucky Network was out of town last week when East Kentucky Network received BellSouth Mobility's motion referenced herein. Counsel, therefore, was unable to discuss the motion with East Kentucky Network until yesterday, Monday, January 24, 2005. In order to properly respond to the lengthy memorandum of law submitted by BellSouth Mobility, counsel to East Kentucky Network needs approximately one week to thoroughly review the legal issues involved and discuss the facts with East Kentucky Network. Thus, East Kentucky Network will file its response no later than Thursday, February 3, 2005.

For these reasons, and the potentially negative impact on East Kentucky Network of the order requested by BellSouth Mobility, East Kentucky Network respectfully requests the


