

**STATUS REPORT OF EAST KENTUCKY NETWORK, LLC

DATED MARCH 8, 2006**


East Kentucky Network, LLC (“East Kentucky Network”), by counsel, pursuant to the Order of the Public Service Commission of the Commonwealth of Kentucky (the “Commission”) dated March 8, 2006, hereby submits its status report regarding the progress of settlement negotiations with New Cingular Wireless PCS, LLC, formerly BellSouth Mobility, LLC (“Cingular”) in the above-referenced case.

On Friday, December 9, 2005, the parties reached an agreement in principal concerning financial terms for the pending Brainard cell site. Since that time, the parties have exchanged redlined versions of a co-location agreement for execution by the parties. East Kentucky Network received the latest version of a co-location agreement from Cingular on Wednesday, March 15, 2006, and is currently reviewing it. In addition, East Kentucky Network received a

request from Cingular on March 15, 2006, to begin gathering documents to facilitate Cingular's co-location. Pursuant to the request, East Kentucky Network has begun gathering appropriate documents.

East Kentucky Network anticipates that the parties will complete their negotiations in the coming weeks and file an executed settlement agreement with the Commission by April 25, 2006, as ordered.
