

**THIRD PROGRESS REPORT OF EAST KENTUCKY NETWORK, LLC
PURSUANT TO THE ORDER OF THE PUBLIC SERVICE COMMISSION
DATED APRIL 21, 2005**

East Kentucky Network, LLC (“East Kentucky Network”), by counsel, pursuant to the Order of the Public Service Commission of the Commonwealth of Kentucky (the “Commission”) dated April 21, 2005, hereby submits its Third Progress Report regarding colocation negotiations with BellSouth Mobility, LLC, d/b/a Cingular Wireless-Kentucky (“Cingular”) in the above-referenced case.

East Kentucky Network has determined that collocation at what it calls its Rough and Tough Cell Site with Cingular is possible, even if the height of the tower is decreased by half. To this end, East Kentucky Network has directed its legal counsel to draft a collocation agreement for submission to Cingular for review and negotiation. East Kentucky Network's


legal counsel has done so and has submitted that collocation agreement to East Kentucky Network for its review. That review should be completed within about two weeks.

The two principal open issues at this time that East Kentucky Network has not resolved internally are the cost of collocation, that is, the collocation charges to Cingular, and whether stress and interference studies should be conducted by a certified engineer employed by East Kentucky Network, at the expense of Cingular.

East Kentucky Network plans on submitting its proposed collocation agreement to Cingular for its review and comment within two weeks. East Kentucky Network also plans on resolving the two open internal issues (described above), that is, the lease payments and engineering study within the same time frame.

Finally, East Kentucky Network anticipates that once the collocation agreement is submitted to Cingular for its review (in about two weeks) that the collocation agreement should be finalized within a week or two thereafter through discussions with Cingular. This means that East Kentucky Network anticipates that this matter should be resolved within the next thirty (30) days or so.
