PETITION FOR CONFIDENTIAL TREATMENT
OF RESPONSE TO DATA REQUEST

Pursuant to 807 KAR 5:001 Section 7, KENERGY CORP. (“KENERGY”) respectfully petitions the Commission to classify and protect as confidential the information relating to salaries of executive officers set forth in Kenergy’s response to Item 19 of the Second Data Request of Commission Staff. As grounds, petitioner states that information of this nature is exempt from disclosure under KRS 61.878(1)(a) which protects information of a personal nature where the public disclosure would constitute a clearly unwarranted invasion of personal privacy.

The Commission has evidenced its policy that public disclosure of personal information of this nature is unwarranted by removing the amounts of annual salaries of Principal Employees in annual report information on its internet website. For instance, prior to 2002 the actual amounts of annual salaries for Kenergy’s


Principal Employees were shown in the annual report information, whereas in 2002 and 2003 this information has been excluded. Attached as “Exhibit A” and “Exhibit B” are copies of Kenergy’s annual report information, with salaries excluded, as shown on the Commission’s website for January 1, 2002, and January 1, 2003, respectively.

The information for which petitioner seeks confidential protection in this case is not known outside of Kenergy and is available within Kenergy only on a need to know basis. Consistent with the Commission’s policy of excluding annual salaries from annual report information, the Commission should classify and protect as confidential the information relating to salaries of executive officers set forth in Kenergy’s said response.



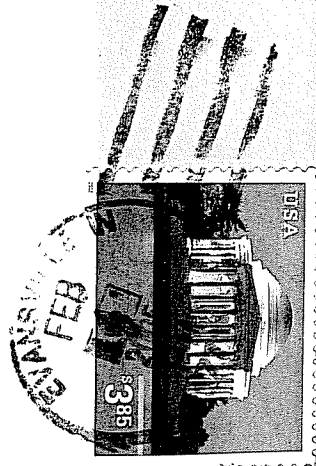
