ANSWER OF LOUISVILLE GAS AND ELECTRIC COMPANY

In accordance with the Kentucky Public Service Commission's ("Commission") Order of December 22, 2004, in the above-captioned proceeding, Louisville Gas and Electric Company ("LG&E") respectfully submits this Answer to the Complaint of John Yuen ("Mr. Yuen") filed on November 16, 2004. In support of its Answer, and in response to the specific averments contained in Mr. Yuen's Complaint, LG&E states as follows:

1. LG&E admits the allegations contained in paragraphs (a) and (b) of the Complaint.
2. With respect to the allegations contained in paragraph (c) of the Complaint concerning the address at 3528 Parthenia Avenue, LG&E states that the former tenant requested that service be disconnected under the tenant's name effective May 7, 2004. In fact, service was disconnected on that date and a final bill was sent to the tenant. The meter was subsequently read in June and July and no consumption of electricity occurred. However, diversion of electric service was subsequently discovered at that address on August 17, 2004. Pursuant to Original Sheet No. 82.1 of LG&E's electric tariff, "[u]pon the absence of an active account, the property

owner assumes responsibility for any consumption and the Company's property and service." Thus, any consumption of electricity at that address after May 7, 2004, became the responsibility of Mr. Yuen as the property owner. Mr. Yuen was properly assessed a charge for the diversion that LG&E discovered on August 17, 2004.

3. LG&E denies all allegations in the Complaint which are not expressly admitted in the foregoing paragraphs of this Answer.

FIRST AFFIRMATIVE DEFENSE

The Complainant fails to set forth any claim upon which relief can be granted by this Commission and, therefore, should be dismissed.

SECOND AFFIRMATIVE DEFENSE


Complainant has failed to set forth a *prima facie* case that LG&E has violated its tariff or any Commission statute or regulation, and the Complaint should be dismissed for that reason.

WHEREFORE, for all of the reasons set forth above, Louisville Gas and Electric Company respectfully requests:

- (1) that the Complaint herein be dismissed without further action being taken by the Commission;
- (2) that this matter be closed on the Commission's docket; and
- (3) that LG&E be afforded any and all other relief to which it may be entitled.


