

**NOTICE OF FILING OF IRREVOCABLE LETTER OF CREDIT AND
OF NAME CHANGE**

Comes ELIZABETHTOWN UTILITIES, LLC, (Now AIRVIEW UTILITIES, LLC), by counsel, and hereby files an Irrevocable Standby Letter of Credit issued by Old National Bank and stamped-filed Articles of Amendment of Elizabethtown Utilities, LLC changing its name to Airview Utilities, LLC.

1. The Public Service Commission's Order of April 28, 2005, ordered Elizabethtown Utilities, to file a letter of credit. Accordingly, Elizabethtown Utilities (now Airview Utilities, LLC) hereby files the Irrevocable Standby Letter of Credit issued by Old National Bank. Old National Bank advised counsel for Airview Utilities, LLC, that the original of said letter of credit had previously been forwarded to the Commission. (See Attachment A).
2. On July 22, 2005, Elizabethtown Utilities, LLC, filed Articles of Amendment with the Office of the Kentucky Secretary of State whereby it changed its name to Airview Utilities, LLC. The reason for the name-change was that the local utility was concerned about the possibility of confusion with billing, etc, if the name was not changed. Accordingly, the name of Elizabethtown Utilities, LLC, was revised to Airview Utilities, LLC. (See Attachment B).


