

APPLICATION FOR REHEARING

Applicant HENDERSON COUNTY WATER DISTRICT (“HCWD”) requests the Commission to modify its April 28, 2005, Order to include rates for customers with a 3 Inch Connection and in support of this request states as follows:

1. In HCWD’s application existing and proposed rates for customers with a 3 Inch Connection were inadvertently omitted. Consequently, the Commission did not approve rates for this class of customers in its April 28, 2005, Order.

2. The Commission should modify its April 28, 2005, Order to include approved rates for 3 Inch Connection customers. Based on the recommendations and findings of Commission Staff, which were adopted by the Commission in said order, and following Commission Staff’s methodology, these rates would be as follows:

	<u>Phase 1</u>	<u>Phase 2</u>
<u>3 Inch Connection</u>		
First 30,000 gallons, Minimum Bill	\$133.61	\$139.93
Over 30,000 gallons, per 1,000 gallons	3.74	3.89


3. Rates for 3 Inch Connection are in HCWD's existing tariff and its new tariff would be incomplete without including the foregoing rates. Further, the inclusion of these rates does not affect test year information or other financial or statistical data set forth in HCWD's application.

4. The approval of rates for 3 Inch Connection customers should relate back to the date of the April 28, 2005, Order so that all rates approved in this case become effective at the same time. Alternatively, HCWD requests that the foregoing rates become effective without delay (HCWD's wholesale rates increased March 1, 2005) and suggests that all rates approved in this case become effective at the same time.

Undersigned counsel for HCWD is authorized to inform the Commission that counsel for the Attorney General, by and through the Office of Rate Intervention, which is the sole intervenor herein, does not object to this application.


**WHEREFORE**, HCWD requests modification of the Commission's April 28, 2005, Order as set forth above and further requests that it be afforded all proper relief.

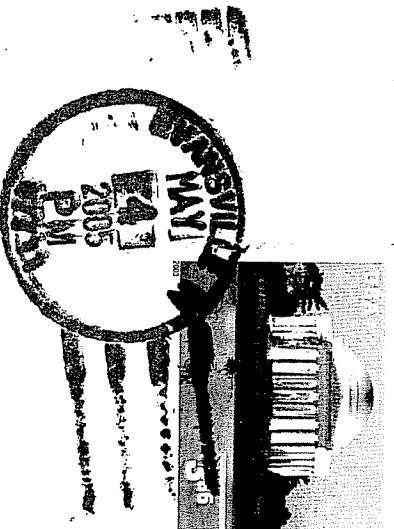
