

WEST DAVIESS COUNTY WATER DISTRICT RATE ADJUSTMENT INCREASE
In accordance with 807 KAR 5:068 and KRS 278:015, West Daviess County Water District has applied for approval from the Kentucky Public Service Commission for a rate increase of 4 cents per 1,000 gallons of water effective June 1, 2005. The rate increase reflects the additional cost of water purchased from Owensboro Municipal Utilities. The change in rates will increase the average residential customer's water bill of 5,500 gallons with a 3/4" meter from \$18.71 to \$18.93, an increase of 1.18%.

In accordance with 807 KAR 5:068 and KRS 278:015, Southeast Daviess County Water District has applied for approval from the Kentucky Public Service Commission for a rate increase of 11 cents per 1,000 gallons of water effective June 1, 2005. The rate increase reflects the additional cost of water purchased from Owensboro Municipal Utilities. The change in rates will increase the average residential customer's water bill of 5,900 gallons from \$15.17 to \$15.82; an increase of 4.28%. The following rates are proposed:
