O R D E R

Louisville Gas and Electric Company, Kentucky Utilities Company and the Office of the Attorney General (collectively “movants”) have filed jointly with the Commission a motion to suspend the procedural schedules in the above-captioned cases. As grounds for their motion, movants assert that they “believe they have reached a tentative settlement of the issues involved ... subject to the approval of the complainants, and the Commission.”<sup>1</sup> Movants request that the Commission schedule an informal conference for the purpose of discussing the tentative settlement.

IT IS THEREFORE ORDERED that:


1. The procedural schedules in the above-captioned cases are suspended generally.
