BellSouth Telecommunications, Inc. ("BellSouth"), by counsel, for its comments in the above-captioned case states as follows:


In the Attorney General's Response to Commission's Order Regarding Motion to Compel filed September 11, 2006, the Attorney General advised the Kentucky Public Service Commission of ongoing settlement negotiations with many of the entities making appearances in this docket. The Attorney General and BellSouth have reached resolution on all issues related to BellSouth in the instant proceeding. BellSouth made some minor revisions in the wording of the BellSouth® Business PlusSM Service plan Price List¹ that were acceptable to the Attorney General. The Attorney General has indicated to BellSouth that no further action will be taken by the Attorney General in this case with regard to BellSouth.

Based on the fact that the referenced services are nonbasic services within the definition set forth in KRS 278.541(5) and are no longer subject to filed tariffs with the Kentucky Public Service Commission, and the Attorney General has reached resolution


