O R D E R

On September 15, 2005, Cumberland Valley Electric, Inc. ("Cumberland Valley") and the Attorney General ("Attorney General"), by and through his office of Rate Intervention, separately moved the Commission to amend the procedural schedule established in this case.

Cumberland Valley requests an extension until September 3, 2005 for filing its responses to the outstanding data requests. Cumberland Valley states in support of its request that it needs additional time due to the volume of data requested and the supporting analyses required to properly respond.

The Attorney General requests that the public hearing scheduled for December 15, 2005 be rescheduled for a date in January 2006. He states in support of his request that he is unavailable on the presently scheduled hearing date due to prior commitments.


