Also what I asked in paragraph #4, is this true? If it is, I really do not see the necessity of this line. If it is not true, what are the advantages.

I have requested a public hearing through your office but have not received an answer yet, I am sure it is coming.

The letter I received before I requested more information was very vague and implied that the line may or may not be coming across my property but I had heard from neighbors that there was a line route established. After hearing this I asked for more information. I feel very strongly that this information should be made public since it has the ability to completely destroy one's life and property. It is not good to not provide specific information when it is available.

There is acre after acre of land in this area that is not "home" property and by looking at the section of map provided it looks like it would even be a better route but again I would need the entire map of the project.

I hope you can provide the information needed since East Kentucky Power Cooperative refers to you as being the provider of more information.

I reviewed the detailed map that you provided to me regarding the East Kentucky Power Company transmission line.

I am sure you realize this but this line is proposed directly in my front yard. It will take out all the landscaping and all of the trees. I have 59.25 acres and it even appears to me if the line went straight instead of making a 20 degree turn to go directly in my front yard, and in fact taking the left front corner of my house, it would be easier. I really need the entire map of this project to see all the turns, if you could so kindly provide me with one.

This house and the 5 acres surrounding it has been appraised for \$400,000.00. The estimated value of this area if a transmission line is in my front yard is \$0.00. I am greatly concerned. There is acres and acres of land very near, just a few yards off that has no homes and is just woods. This area seems more appropriate to me.

It is also my understanding that East Kentucky Power will not be providing electricity for any additional members than is already being served now and that the cost of electricity will not go down as a result of this project. Am I correct in this?
If not please explain.

Please contact me at the earliest possible time convenient for you and please send the map requested as soon as possible.

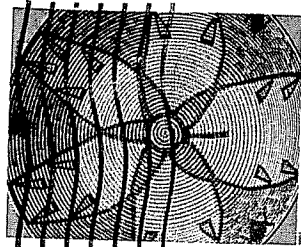
