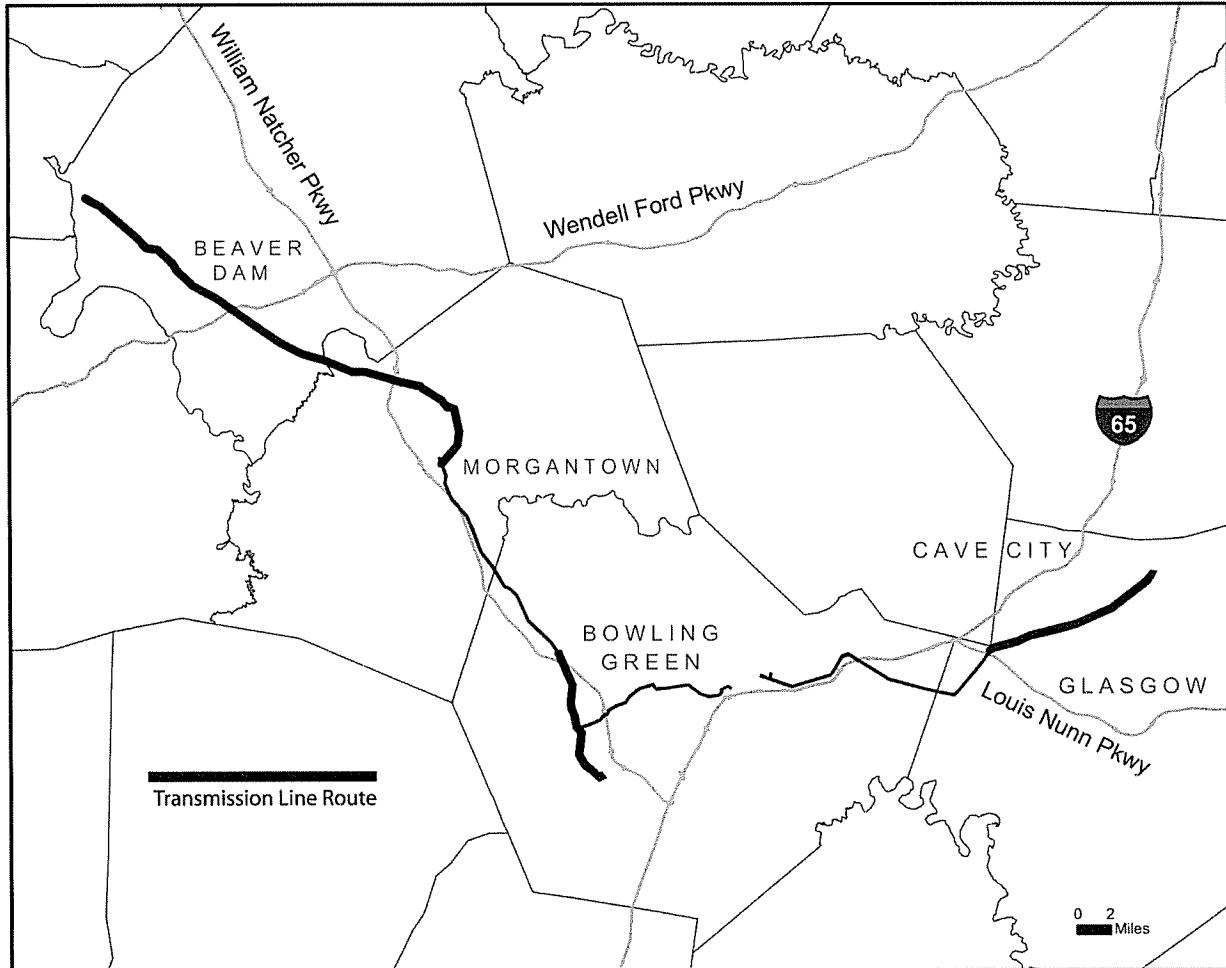

Proposed Route of 161-kV Transmission Line



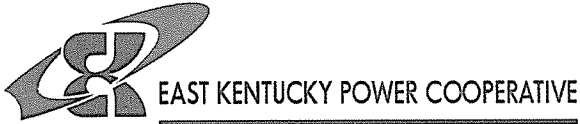
