APPLICATION

COMES NOW Kentucky ALLTEL, Inc. ("Kentucky ALLTEL") and, pursuant to K.R.S. §278.020(3), applies for a certificate of convenience and necessity that there is a demand and need for continued local telephone service within the territorial limits of Midway, Kentucky ("Midway") and states as follows:

1. Kentucky ALLTEL is an incumbent local exchange carrier ("ILEC"), certified to and providing telecommunications services in Kentucky and maintaining its principal place of business in the Commonwealth at 230 Lexington Green Circle, P.O. Box 1650, Lexington, Kentucky 40588. Kentucky ALLTEL's Articles of Incorporation and amendments thereto have been previously filed with this Commission.

2. As Midway proposes to offer for sale a new franchise for the construction, operation, and maintenance of a telecommunications system within its territorial limits, a new certificate is required to permit Kentucky ALLTEL to bid on the new franchise.

3. Kentucky ALLTEL currently provides basic local exchange service in Midway and utilizes portions of the public rights-of-way to transmit and distribute certain aspects of said service. Many of the residents and business firms located in Midway subscribe to the

telephone service of Kentucky ALLTEL and depend upon such for communication within Midway. Such demonstrates the need and demand for continued telephone service within Midway.

4. Pursuant to K.R.S. §278.020, no finding or determination as to the qualifications of the bidder or the validity of any of the provisions of the new franchise offered by Midway is required. Further, nothing in this Application is intended to be construed as an application for a certificate of convenience and necessity to construct utility facilities under K.R.S. §278.020.

WHEREFORE, Kentucky ALLTEL requests that the Commission issue a certificate that public convenience and necessity require the continued provision of local telephone communication service within Midway's territorial limits and that Kentucky ALLTEL be authorized to bid upon a new franchise for the provision of such service.
