COMMISSION STAFF'S SECOND INFORMATION REQUEST
TO THE CITY OF VERSAILLES

Pursuant to Administrative Regulation 807 KAR 5:001, Commission Staff requests that the city of Versailles ("Versailles") file with the Commission the original and 8 copies of the following specified information, with a copy to all parties of record. The information requested herein is due on or before April 17, 2006. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information requested herein has been provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request. When applicable, the information requested herein should be provided for total company operations and jurisdictional operations, separately.

1. In its responses to Staff's information request, Versailles stated that the water flows through its entire water system to serve both wholesale customers. Are the majority of the water system lines dedicated to distribution mains for city customers?

a. If the majority of mains are dedicated to the city customers, is it not true that the majority of expenses related to the production and distribution of the water should be borne by the city customers and not the wholesale customer?

b. With the above as a guide, provide the information in the table as the amount of lines that are used as a transmission line to serve your wholesale customers.

3. In response to the IC and the follow-up letter, Versailles has stated that the rate charged to its wholesale customers is different than the rate stated in the tariff that the Commission has on file.

a. Can you explain why the rates being charged are different from what is in the tariff? If so, explain.

b. Versailles stated at the IC that the proposed increase is an across-the-board 18 percent increase. Refer to the table below. The proposed rates do not represent an 18 percent across-the-board increase. Explain how the proposed rates

were established. Provide all workpapers, state all assumptions that were used, and show all calculations in formulating the rates as proposed by Versailles.

Refer to the City of Versailles Audited Financial Statements and Supplemental Information for the year ended June 30, 2005 at 15, Changes in Net Assets Proprietary Fund for the year ended June 30, 2005. On this schedule are the revenues and expenses for the combined water, sewer, and sanitation divisions. Does Versailles have a schedule showing each division separately? If yes, provide. If no, explain how the rates for each division is calculated.

6. For each revenue bond listed below, state the original purpose of the issuance, provide a copy of the bond ordinance, provide an amortization schedule for each issuance, provide an allocation of the annual debt service payment and the outstanding balance as of June 30, 2005, between each division (water, sewer, and sanitation divisions).


c. Explain why Kevin Rexroat and John Lopez do not have salaries listed on the schedule.
