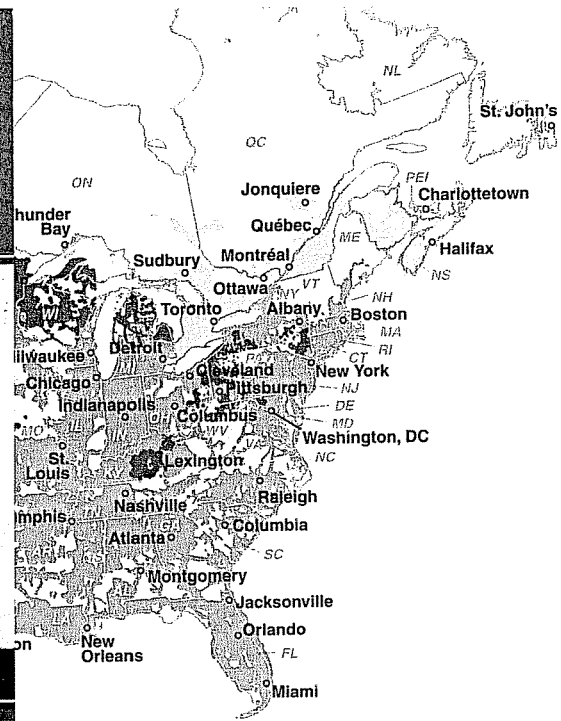
terms and conditions

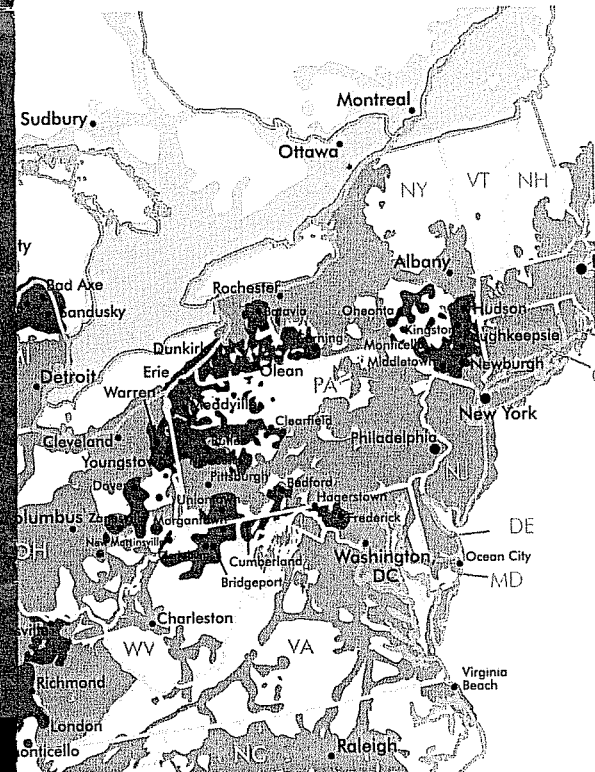

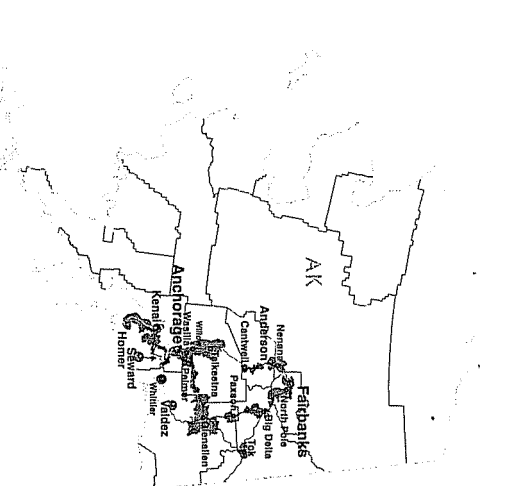

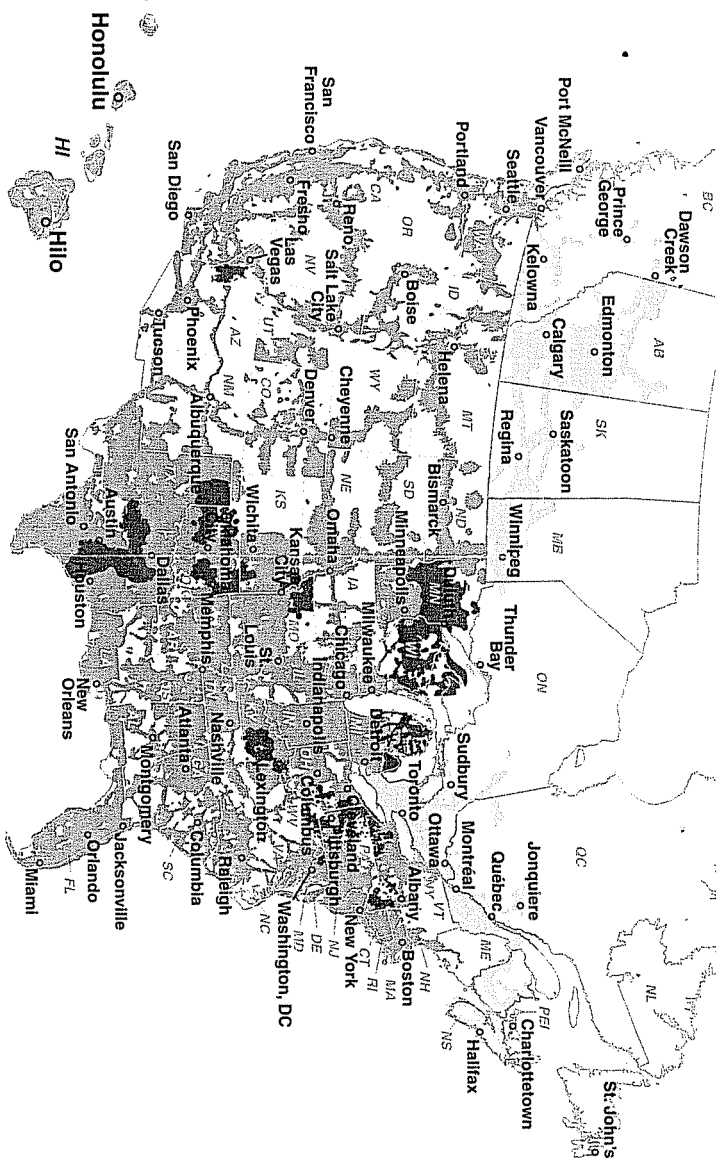
