NPCR, Inc. d/b/a Nextel Partnership ("Nextel") is requested, pursuant to 807 KAR 5:001, to file with the Commission the original and five copies of the following information, with a copy to all parties of record. The information requested herein is due 20 days from the date of this request. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the person who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information herein has been previously provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request.

1. Provide any and all documentation to verify that the service term of the original Subscriber Agreement was changed from the original 1-year term beginning March 17, 2004 to a 1-year term beginning January 10, 2005.

2. Explain how the service term contained in the original Subscriber Agreement can be verbally changed when the company's "Terms and Conditions" contains a provision for making changes in writing only.

3. Provide copies of any and all documents that were created or sent to the customer after the acceptance of the specialized price plan referred to in Paragraph 3 of the Answer.

4. Provide a copy of the bill sent to Complainant assessing the \$200 early termination fee.

5. Refer to Nextel's Answer, Paragraph 7. Explain the distinction between NPCR, Inc. and NPCR, Inc. d/b/a Nextel Partnership.
