Kentucky Frontier Gas, LLC. is the contract operator for the Floyd County gas system through a Service Agreement with East Kentucky Utilities, Inc. (EKU) We assumed operations of the system on August 15, 2005.

On behalf of EKU we are filing the enclosed revised Gas Cost Recovery for the period November and December, 2005. We just received today, the enclosed copy of Exhibit "A" to our gas purchase agreement with Equitable Energy. Their price of \$15.80 is significantly higher than the \$13.39 that we had estimated, based on NYMX futures prices, and used in our calculations. Equitable was the only company, of six that we contacted, to make a gas supply proposal. Enclosed is a revised Rates and Charges Form and related calculations utilizing Equitable's \$15.80 price. We respectfully request a waiver of the 30 notice requirement for this filing.
