O R D E R

On December 8, 2005, East Kentucky Power Cooperative, Inc. ("East Kentucky") filed an application for approval of the construction of a transmission line in Rowan County, Kentucky. Pursuant to KRS 278.020(8), "The commission shall issue its decision no later than ninety (90) days after the application is filed, unless the commission extends this period for good cause, to one hundred twenty (120) days."

On December 14, 2005, East Kentucky filed a motion requesting that the Commission "Expedite the Schedule in these proceedings to the extent that is possible," but it does not otherwise request any specific relief. The motion states as grounds for expediting the schedule that (1) the Commission will not need a consultant in this case because the need for the line is not an issue and (2) the risk of outages and high re-dispatch costs increases as long as the new line is not installed.

The Commission finds that the extension authorized by KRS 278.020(8) is warranted in this case. As the November 23, 2005 Order in this case stated, "the consultant in Case No. 2005-00089, MSB Energy Associates, Inc. . . . specifically

advised the Commission on alternative routes, and the Commission intends to use the same consultant in deciding the present case.” Moreover, the line runs through the Daniel Boone National Forest, where it has already generated significant opposition, and the Commission expects that opposition to continue in this certificate proceeding. For these reasons, the Commission finds that the time period in which it must issue a decision in this case should be extended to 120 days.

Incorporating this extension, the Commission also issues a preliminary procedural schedule setting dates for certain events. The Commission reserves the right to amend this procedural schedule as needed.

The Commission is mindful of East Kentucky’s fears of outages and high re-dispatch costs. To the degree that this case can be completed in fewer than 4 months, we will endeavor to do so, and to that extent, East Kentucky’s motion to expedite the schedule is granted. Limiting such a controversial case to no more than 3 months, however, would place very difficult restrictions on other parties and the Commission, so to the degree that the motion requested that the time for the case not be extended, it is denied.


IT IS THEREFORE ORDERED that:
