O R D E R

On January 27, 2006, Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") filed a Notice and Motion For Corrected Finding of Administrative Completeness in these dockets, which are an application for approval of the construction of a transmission line in Jefferson, Bullitt, Meade, and Hardin counties, Kentucky and an application for approval of the construction of an alternative line in the same counties. In a January 25, 2006 notice and again in this most recent filing, LG&E/KU reported that they had failed to give notice to certain landowners in the path of the proposed lines.

The Commission issued an initial procedural schedule in these cases by Order dated January 6, 2006, based on the filing of completed applications on December 22, 2005. The portions of the Order consolidating the cases and extending the time for processing them to 120 days remain in effect. With the notice deficiencies LG&E/KU have now reported, however, the procedural schedule must be revised to reflect that the applications were not complete until January 27, 2006.

The Commission therefore issues the attached new preliminary procedural schedule. The new date for the local public hearing is March 2, 2006 in Elizabethtown, and the hearing in Frankfort will begin on March 28, 2006. The Commission may amend this schedule by later Order.


IT IS THEREFORE ORDERED that:
