Dear [REDACTED]

On December 20, 2005, Kentucky Utilities (KU) wrote to you to explain that we plan on constructing a 345,000 volt electric transmission line from the Mill Creek generating station in Jefferson County to KU's Hardin County substation. In that letter we explained that Part of the planned line may cross your property in [REDACTED] County. However, we only notified you of the alternative route we have proposed and indicated that our preferred route would not cross your property. Since sending the December 20 letter, we have determined that the preferred route would cross a corner of your property if approved. We are sending this letter to correct the inaccurate information in our earlier letter and notify you of the preferred route. A map of the preferred route is enclosed.

KU applied to the Kentucky Public Service Commission for regulatory approval for construction of the preferred line on December 22, 2005. The Commission has assigned the case docket number 2005-00467.

KU also applied to the Commission for regulatory approval of the alternative line described in our December 20 letter on December 22, 2005. The Commission assigned that case docket number 2005-00472. As we explained in our earlier letter, the alternative route is KU's second choice and would only be approved by the Commission if the Commission declines approval of KU's preferred route. Either route would cross your property but would cross in different places.

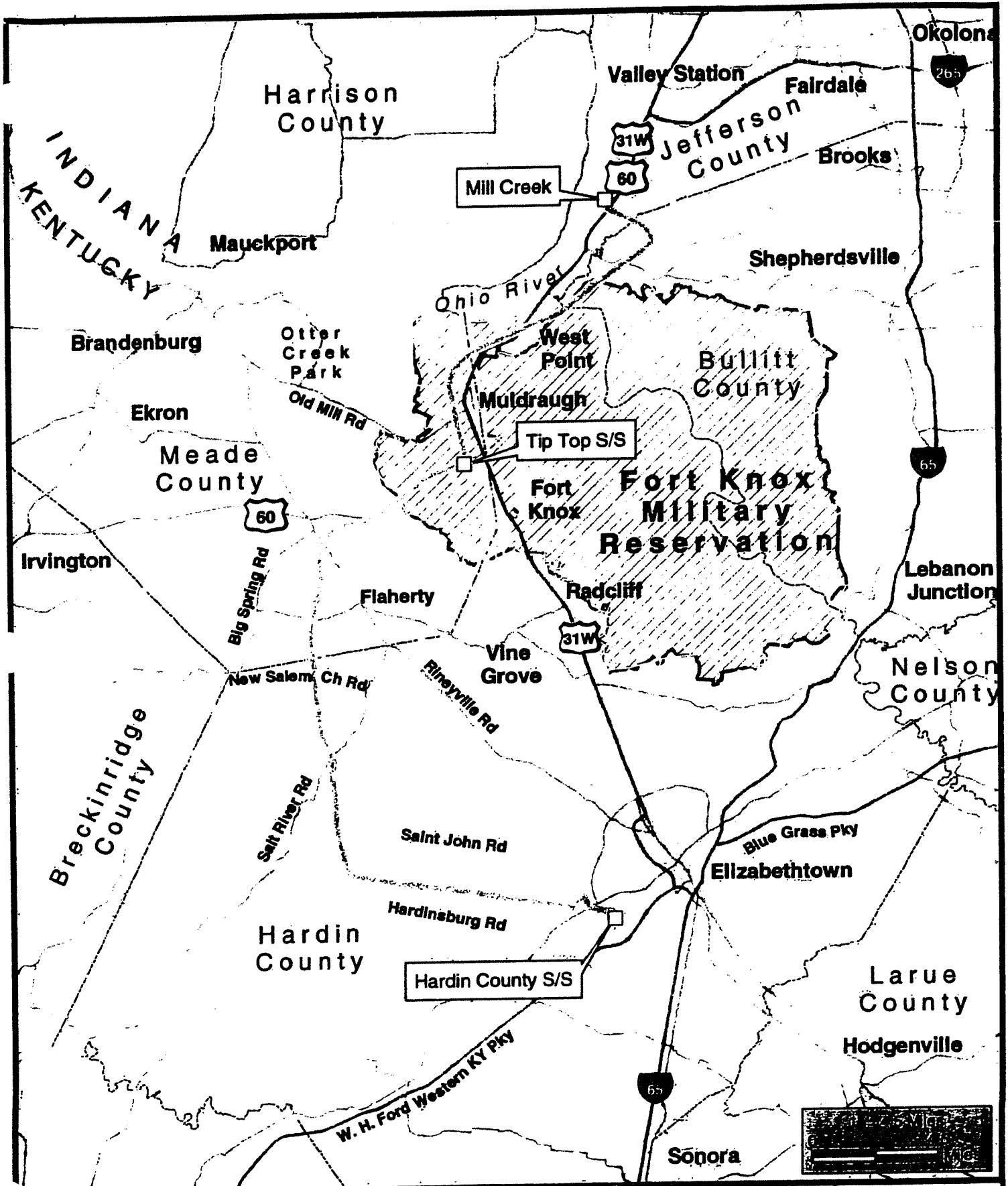
