O R D E R

The Commission herein reopens these matters to address the issue of moneys owed to BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky"), if any, by SouthEast Telephone, Inc. ("SouthEast"). This matter was remanded to the Commission in an Opinion and Order of the United States District Court, Eastern District of Kentucky.<sup>1</sup> On November 9, 2007, AT&T Kentucky filed a motion for the issuance of a damages award on an expedited basis. As yet, SouthEast has had insufficient time to respond to this motion.

In order to address this remand in the most efficient manner possible, the Commission finds that an informal conference is needed to address all matters, including calculation of any moneys due.<sup>2</sup>

IT IS HEREBY ORDERED that:

1. By November 29, 2007, SouthEast shall file its response to the motion for issuance of a damages award.
2. Both parties shall appear for an informal conference with Commission Staff on December 6, 2007, beginning at 1:30 p.m., Eastern Standard Time, in Conference Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.
