On January 17, 2006, Atmos Energy Corporation ("Atmos") filed its request to terminate the filing requirements ordered by the Commission in Case No. 1998-00224.<sup>1</sup> In that case, the Commission approved Atmos's request to create and issue 650,000 shares of common stock through its Restricted Stock Grant Plan and required Atmos to notify the Commission on a semi-annual basis of the number of shares it had issued. Since Atmos has now issued all 650,000 shares, it requests that the Commission no longer require it to file a report.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that the filing requirements in Case No. 1998-00224 should be terminated.
