

FOR SECOND EXTENSION OF TIME TO RESPOND TO
COMMISSION STAFF'S FIRST INFORMATION REQUEST**

Comes the Applicant, Farmdale Development Corporation ("Farmdale"), by counsel, and for its Motion for Second Extension of Time to Respond to the Commission Staff's First Information Request states as follows:


1. On October 4, 2006, the Commission Staff's First Information Request to Farmdale was issued in the above styled action requesting Farmdale to file with the Commission no later than 14 days from the date of the First Information Request, information concerning each item proposed to be repaired or replaced in the Amended Application, to describe the repair or replacement that will be performed and to provide bids or estimates from three non-affiliated sources to support each of Farmdale's costs estimates. Farmdale's answers to the First Information Request were therefore due on or about October 18, 2006.

4. The Amended Application identified the following items as needing repair and/or maintenance: Collection system repairs, lagoon pump and clean, replace chlorine tank, standby motor assembly, replace diffuser drop pipes, small plant maintenance, lift station grating and temporary repairs.

5. By Order dated October 20, 2006, the Commission granted Farmdale an extension of time to respond to the Commission Staff's First Information Request through and until November 20, 2006.

6. Farmdale has requested additional bids on items needing repair and/or maintenance, but has not yet received all of the responsive bids. Accordingly, Farmdale requests a second extension of time of twenty (20) days within which to receive responsive bids and to file its Answer to the Commission Staff's First Information Request.


