On February 22, 2006, Parksville Water District ("Parksville District") applied for authority to revise certain non-recurring charges. Because of deficiencies in Parksville District's application, the Commission did not accept this application for filing until March 13, 2006. Parksville District has provided adequate evidence of the individual expenses incurred to provide the services associated with the proposed charges.

The Commission, having reviewed the record and being sufficiently advised, finds that:
