Filing Deficiencies

Parksville Water District has received the Commission's letter concerning the filing deficiencies in the above referenced case. The District response follows.

1. Filing Deficiencies pursuant to 807 KAR 5:011:

In the letter, dated February 17, 2006, that accompanied the initial filing of case no. 2006-00081, the District stated that the requested increase in non-recurring charges would increase the total revenues by more than five (5) percent. This statement was incorrect and the result of the District's misinterpretation of 807 KAR 5:011: Section 2. This error became apparent to the District after consultation with Commission Staff on March 6, 2006. **The requested increase in non-recurring charges will not increase the total revenues of the District by more than five (5) percent.**

Pursuant to 807 KAR 5:011: Section 8, the District has re-advertised notice of the filing of the above referenced case with a new proposed effective date of June 1, 2006. The notice was published in the *Advocate-Messenger*, the newspaper of general circulation in the District's service area, on March 8, 2006. A copy of the notice is enclosed. The District will forward to the Commission the tear sheets of the published notice, and an affidavit of publication from the publisher once they are received by the District.

2. Filing deficiency pursuant to KRS 278.180:


The District has given thirty (30) days notice to the Commission by publishing the new advertisement showing an effective date of June 1, 2006.
