Comes the Applicant, Powertel/Memphis, Inc., by counsel and for its Response to Notice of Filing Deficiencies, submits the following Response.

Cited deficiency 3: A list of the property owners who received the notice together with copies of the certified letters sent to listed property owners.

Copies of the original letters mailed to said property owners are included with this Response as Exhibit 1. Copies of the amended notice letters are included in Exhibit 2 to this Response. The amended letters also were sent by certified mail, return receipt requested.

Cited deficiency 4: A statement that the local county judge executive has been notified by certified mail of the proposed construction.

Response: This statement is included in the second sentence of Paragraph 16.


Cited deficiency 5: A statement that the local county judge has been given the Commission docket number under which the application will be processed.

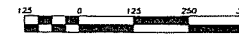
