JOINT MOTION TO SUBMIT CASES FOR DECISION ON THE RECORDS

Kentucky Utilities Company (“KU”), Louisville Gas and Electric Company (“LG&E”), Kentucky Industrial Utilities Customers, Inc. (“KIUC”), and the Kentucky Office of the Attorney General, Utility and Rate Intervention Office (“AG”) hereby move the Kentucky Public Service Commission (“Commission”) to decide all of the issues presented in these cases on the bases of the records as filed.

On December 5, 2006, the Commission issued Orders in these proceedings that set a procedural schedule for Commission Staff and interveners to submit data requests to the Companies concerning their recent corrections made to previously filed direct testimony, data responses, and their joint post-hearing brief. In the December 5, 2006 Orders, the Commission

stated, “[T]he intervening parties may again indicate whether this case may be submitted without a hearing or whether they believe a hearing might be requested.” The AG and KIUC, having reviewed the Companies’ corrected filings, and having determined that they have no additional data requests or concerns about the filings and that no additional hearing is necessary, hereby join the Companies in moving the Commission to decide all issues in these proceedings on the bases of the records filed.

WHEREFORE, Kentucky Utilities Company, Louisville Gas and Electric Company, Kentucky Industrial Utilities Customers, Inc., and the Kentucky Office of the Attorney General, Utility and Rate Intervention Office respectfully request that the Commission decide all issues in these proceedings on the bases of the records filed.


