MOTION TO CORRECT ORDER

Kentucky Utilities Company ("KU") hereby respectfully moves the Public Service Commission ("Commission") to issue an Order nunc pro tunc correcting its January 31, 2007 Order ("Final Order") in this proceeding. In the body of the Final Order's text, the Commission correctly stated:

> The Commission has reviewed and finds reasonable KU's calculation of a net under-recovery of \$1,597,499 for the billing periods covered in this proceeding. The Commission also finds reasonable KU's proposal to increase the total jurisdictional environmental surcharge revenue requirement in each of the first 4 billing months following the date of this Order, with the increase in the first 3 months being \$399,375 and the increase in the fourth month being \$399,374.¹

In the first ordering paragraph of the Final Order, however, there appears to be a typographical error, which is bolded and underlined in the excerpt below:

> KU shall include a \$339,375 monthly increase in its jurisdictional environmental revenue requirement determined in the first 3 billing months following the date of this Order and \$399,374 in the fourth month following the date of this Order, as discussed herein.²

Because the body text of the Final Order shows it was not the Commission's determination to grant a \$339,375 monthly increase, but rather a \$399,375 increase, KU respectfully moves the Commission to issue an Order correcting the first ordering paragraph of the Final Order accordingly.

WHEREFORE, Kentucky Utilities Company respectfully moves the Commission to enter an Order *nunc pro tunc* correcting the Commission's Final Order in this proceeding, dated January 31, 2007, by replacing the first ordering paragraph, which currently reads (with emphasis added):

KU shall include a \$3**3**9,375 monthly increase in its jurisdictional environmental revenue requirement determined in the first 3 billing months following the date of this Order and \$399,374 in the fourth month following the date of this Order, as discussed herein.³

with the following text:

KU shall include a \$399,375 monthly increase in its jurisdictional environmental revenue requirement determined in the first 3 billing months following the date of this Order and \$399,374 in the fourth month following the date of this Order, as discussed herein.
