As grounds for this Motion, LG&E states that while preparing its responses to Appendix B of the Commission's April 25, 2006 Order, questions about the accuracy of the data were raised that need to be addressed in order to present accurate information in the filing and a correct calculation of the over- or under- recovery amount. The requested additional extension of time is necessary to review and ensure the accuracy of such data and the calculation of the over- or under- recovery amount. This Motion for Extension of Time is not made for the purpose of unduly delaying the Commission's examination and if granted will not prejudice the Commission's ability to conduct its examination.

WHEREFORE, Louisville Gas and Electric Company respectfully requests that the Commission issue an order granting an extension of time through and until Wednesday, June 14,

2006 to file responses to Appendix B of the Commission's April 25, 2006 Order and retain the date for the June 20, 2006 informal conference.
