MOTION FOR EXTENSION OF TIME

Louisville Gas and Electric Company ("LG&E") hereby moves the Kentucky Public Service Commission ("Commission") for an extension of time through and until Monday, June 19, 2006 in which to file the testimony of Mr. Robert M. Conroy in this matter and also in which to submit its responses to Item Nos. 1 and 2 of Appendix B to the Commission's April 25, 2006 Order. LG&E will submit this information to the Commission and the intervenors as soon as possible, but no later than Monday, June 19, 2006.

As grounds for this Motion, LG&E states that while preparing its responses to Item Nos. 1 and 2 of Appendix B to the Commission's April 25, 2006 Order, questions about the accuracy of the data were raised that need to be addressed in order to present accurate information in the filing. The requested additional extension of time is necessary to ensure the accuracy of the calculation of the over- or under- recovery amount. This Motion for Extension of Time is not made for the purpose of unduly delaying the Commission's examination and if granted will not prejudice the Commission's ability to conduct its examination. On or before Monday, June 19, 2006, LG&E will submit the testimony of Mr. Robert M. Conroy, as well as, its responses to Item Nos. 1 and 2 of Appendix B to the Commission's April 25, 2006 Order as soon as it

becomes available. LG&E further commits to provide such information to intervening counsel on Monday by both electronic and regular mail. LG&E requests the Commission retain June 20, 2006 as the date for the informal conference.

WHEREFORE, Louisville Gas and Electric Company respectfully requests that the Commission issue an order granting an extension of time 2006 to file the testimony of Mr. Robert M. Conroy in this matter and also to submit its responses to Item Nos. 1 and 2 of Appendix B to the Commission's April 25, 2006 Order as soon as possible, but no later than through and until Monday, June 19, 2006.
