RATES

The Kentucky River Authority Withdrawal Fee authorized to be imposed upon all customers of Kentucky-American Water Company in accordance with the tariff shown in First Revised Sheet 55 shall be a rate of \$.00113 per 1,000 gallons or \$.00085 per 100 cubic feet.

Except for rate changes imposed by the Kentucky River Authority, which will be put in effect immediately upon notification of such change by the Kentucky River Authority, this fee will be adjusted annually beginning January, 2002 to reflect any over or under collection of Kentucky River Authority fees existing at the time of the adjustment. No adjustment will be made if the over or under collection is immaterial.
