O R D E R

This matter arises upon the motions of The Kroger Company and St. Elizabeth Medical Center (hereinafter referred to collectively as "Petitioners") filed June 1, 2006 and June 15, 2006, respectively, for full intervention. It appears to the Commission that the Petitioners have a common interest, they are represented by the same counsel, and that their joint intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission, being otherwise sufficiently advised, finds that the Petitioners should be granted joint intervention with the full rights of a party in this proceeding.


IT IS HEREBY ORDERED that:
