**NOTICE OF SATISFACTION OF COMPLAINT**


The above-named defendant New Cingular Wireless PCS, LLC (“Cingular”), by counsel, respectfully states as follows in response to the Complaint filed in this proceeding:

1. Without admitting or otherwise responding to any of the allegations set forth in the Complaint, Cingular desires to satisfy the Complaint pursuant to 807 KAR 5:001 § 12(5).
2. Cingular has provided the following relief to Complainant: (i) credited Complainant’s account in full for the outstanding balance at issue; (ii) recalled the account from the outside collection agency, and (iii) reversed any negative credit history associated with the account.
3. Prior to submitting this filing, Cingular attempted to contact the Complainant concerning the foregoing relief by telephone on several occasions and by mailing a letter on June 15, 2006 to the Complainant describing the relief and actions set forth in paragraph 2 above. 
