

This letter is in response to your letter of inquiry dated February 8, 2007 and your follow-up letter dated February 16, 2007. The February 16, 2007 letter addressed our previous phone discussions. Based on our phone conversations and the information you provided with your letter, the Division of Water has determined that a construction permit will not be necessary to replace the pump station at Farmdale wastewater treatment plant.

The lift station shall be installed in accordance with the requirements of Regulation 401 KAR 5:005 and Ten States Standards, 1990 Edition.
