Dear Ms. O'Donnell:

The purpose of this letter is to inform the Public Service Commission that the RLECs and the CMRS Providers have reached an agreement with respect to parts of their respective, pending motions for rehearing/clarification. That agreement is as follows.

The CMRS Providers have agreed not to contest the RLECs' Motion for Clarification of Single Issue, filed on January 12, 2007. In exchange, the RLECs have agreed not to contest Section VII of the CMRS Providers' motion for rehearing, filed on January 16, 2007.

That is, the CMRS Providers agree that the RLECs should be permitted to, on an individual basis, either: (i) file a TELRIC study; or (ii) use the Commission-approved proxy reciprocal compensation rates for the duration of that RLEC's particular interconnection agreement. In exchange, the RLECs agree that, if an RLEC files a TELRIC study for review and approval by the Commission, any CMRS Provider that RLEC intends to charge the proposed TELRIC study rate may intervene and participate fully in the review and consideration of the proposed TELRIC rate.


