O R D E R

Pursuant to 807 KAR 5:056, the Commission, on July 6, 2006, established this case to review and evaluate the operation of the fuel adjustment clause ("FAC") of American Electric Power Company ("AEP") for the 6 months ended April 30, 2006. A public hearing was held on September 19, 2006.

At the hearing, AEP provided proof of publication of the notice for the hearing in 18 of the 20 publications in which it intended to provide notice of the hearing. Two of the publications failed to publish the notification. On its own motion, the Commission continued the hearing for this proceeding until AEP has had an opportunity to provide proper notice in these two publications.

IT IS THEREFORE ORDERED that:

1. AEP shall appear at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky on October 19, 2006 at 9:00 a.m., Eastern Daylight Time, to submit to further examination on its FAC for the period from November 30, 2005 through April 30, 2006. Neither opening statements nor witnesses' summaries of pre-filed testimony will be permitted.


2. AEP shall notify its customers in writing of the date, time, place, and purpose of the hearing or shall publish notice in accordance with 807 KAR 5:011, Section 8(5). AEP shall file an Affidavit of Publication of Hearing Notice with the Commission on the day of the hearing.

3. The official record of the proceeding shall be by video only, unless otherwise requested by a party to this proceeding.
