Taylor County Rural Electric Cooperative Corporation ("Taylor County") filed its application on June 13, 2006 for a Certificate of Public Convenience and Necessity ("CPCN") to construct certain improvements and additions to its existing plan at an estimated cost of \$14,641,618. In support of its application Taylor County filed its 2006-2009 Work Plan, which describes in detail the improvements and additions to its plant that are required over the next 3 years to serve its load.

Taylor County seeks authorization to construct extensions and additions to its plant as follows:

1. Line Extensions	\$ 4,192,500
2. Transformers & Meters	4,478,725
3. Line Conversions and Changes	2,702,030
4. Service Wires for Increased Capacity	143,220
5. Sectionalizing Equipment	559,525
6. Line Regulators	156,000
7. Line Capacitors	39,000
8. Poles Replacement	1,181,250
9. AMR System & Equipment	872,568
10. Security Lights	<u>316,800</u>
 TOTAL	 \$14,641,618

The proposed construction will enable Taylor County to continue to provide adequate and dependable electric service to its customers. The system improvements

recommended in this Work Plan will not duplicate existing facilities and are needed to correct voltage problems, improve phase balance, and provide for improved service reliability.


Based on the application, the supporting 2006-2009 Work Plan, and being otherwise sufficiently advised, the Commission finds that the proposed improvements and additions to be constructed by Taylor County are necessary to provide adequate, reliable electric service to existing customers and anticipated new customers.

IT IS THEREFORE ORDERED that Taylor County is granted a CPCN to construct the facilities described in its 2006-2009 Work Plan
