O R D E R

On May 21, 2008, Ballard Rural Telephone Cooperative Corporation, Inc.; Duo County Telephone Cooperative Corporation, Inc.; Logan Telephone Cooperative, Inc.; West Kentucky Rural Telephone Cooperative Corporation, Inc.; North Central Telephone Cooperative Corporation; South Central Rural Telephone Cooperative Corporation, Inc.; Brandenburg Telephone Company; Foothills Rural Telephone Cooperative Corporation, Inc.; Gearheart Communications, Inc. d/b/a Coalfields Telephone Company; Mountain Rural Telephone Cooperative Corporation, Inc.;

Peoples Rural Telephone Cooperative Corporation, Inc.; Thacker-Grigsby Telephone Company, Inc.; and New Cingular Wireless PCS, LLC and Cincinnati SMSA Limited Partnership (collectively, "AT&T Mobility"); and Cellco Partnership d/b/a Verizon Wireless; GTE Wireless of the Midwest Incorporated d/b/a Verizon Wireless; and Kentucky RSA No. 1 Partnership d/b/a Verizon Wireless (collectively, "Verizon Wireless") jointly moved for an extension of time to file certain executed interconnection agreements, as required by the Commission's May 1, 2008 Order in this matter. Pursuant to the May 1, 2008 Order, the interconnection agreements were due to be filed by May 21, 2008. As required, a majority of the agreements were filed by that date. In their request for an extension of time, the parties state that only the following agreements remain to be filed: (a) AT&T Mobility-Ballard; (b) AT&T Mobility-Duo County; (c) AT&T Mobility-South Central; (d) AT&T Mobility-West Kentucky; (e) Verizon Wireless-Ballard; (f) Verizon Wireless-Brandenburg; and (g) Verizon Wireless-West Kentucky. The parties state that the extension of time is needed only to facilitate the signing of each remaining interconnection agreement. The Commission finds the parties' request to be fair and reasonable.

Having reviewed the parties' joint motion and all relevant information, and having been otherwise sufficiently advised, the Commission HEREBY ORDERS that the joint motion for extension of time until May 30, 2008 to file the remaining interconnection agreements is granted.
