The following is a delineation of actions taken by the Applicants, or on behalf of the Applicants by others, including reference to and copies of documents produced by the Applicants or by others, included as exhibits, with specific reference to the Ordering paragraphs set out and beginning on page 13 of the Commission's Order dated 1-22-07 in the case referenced above.

Commission:

"1. The proposed transfer of Sandy Valley District's facilities to Southern District and Pikeville, as described in the Joint Application and the Joint Applicants' responses to discovery requests, is approved subject to the conditions set forth below:

a. The transfer shall not occur until Rural Development and the U.S. Economic Development Administration has approved Sandy Valley District's delegation of all obligations arising out of its outstanding debt to Pikeville and Southern District and releases Sandy Valley District of all obligations related to that debt."

Applicant Action:

Re: RD Bonds

- 1. All Applicants signed a memorandum directed to Rural Utilities Service-USDA-Rural Development (RD) (attached as Exhibit 1.a.1) requesting approval of debt assignment and assumption.
- Southern and Pikeville retained bond counsel (Mr. W. Randall Jones, Attorney, Rubin & Hayes, Louisville, KY) who prepared the appropriate draft order/ordinance, notice of bond sale, and saw to the publication of same for Southern and Pikeville respectively, pursuant to bond closing instructions issued by RD.
- 3. Southern took the required bond action on May 24, 2007. Pikeville had first reading of the requisite bond ordinance on May 7, 2007 and second reading and passage of the ordinance on May 29, 2007.
- 4. RD Bond Closing for Southern was conducted at McDowell, KY at 11:00 a.m. and for Pikeville at 2:00 p.m. at Pikeville, both on Wednesday, May 30, 2007.

Re: Economic Development Administration (EDA) Loan

By agreement with EDA Project Manager, Mr. Ken Kukovich, Washington, D.C. the City of Pikeville executed electronic payment of the remaining unpaid balance due EDA on the subject Sandy Valley loan as of May 30, 2007, in the amount of \$13,279; by ancillary agreement executed between Southern and Pikeville, Southern will reimburse Pikeville 43% of this amount, or \$5,709.97.

"b. Southern District and Pikeville shall retain as employees all persons whom Sandy Valley District employed as of January 1, 2006, for a period of at least one year following the date of the transfer and shall pay those persons at a rate that is not less than their pay rate on the date of this Order."

Applicant Action:

All five (5) Sandy Valley employees, employed as of January 1, 2006 and who remained in the employ of Sandy Valley as of February 1, 2007 were offered employment, by letters dated February 13, 2007, with either Southern or Pikeville, at the bi-weekly gross rate of pay as indicated:

Note: Response from prospective employees was requested by March 1. To date, Mr. Greg Clark has accepted employment with Pikeville; Mr. Mike Hall has submitted personal information regarding health insurance, indicating his desire to be employed by Southern. Ms. Pat Layne opted to retire, effective May 30, 2007. Employment for those employees accepting the job offer with the respective Applicant commences effective June 1, 2007.

"c. For a period of one year following the date of the transfer, Southern District and Pikeville shall provide retail water service to Sandy Valley District customers at rates that do not exceed Sandy Valley District's present rates. Thereafter, any adjustments to the rates that Southern District or Pikeville assess to current Sandy Valley District customers for water service shall be made only upon Commission approval or after the performance of a cost-of-service analysis that is prepared by a certified public accountant or other qualified person and whose findings support the proposed adjustment."

Applicant Action:

Southern and Pikeville have acknowledged and agree to the condition as stated above. Further, Pikeville, Southern and Mountain Water District (the later is not an applicant in Case No. 2006-00327) have agreed among themselves and subsequently met with and authorized Ms. Carryn Lee, a qualified individual, to perform a cost of service analysis and rate recommendation relating to Pikeville's wholesale water rates. Additionally, Pikeville intends to retain this same individual to assess its retail rates for both water and sewer services for future consideration.

"d. Unless authorized or directed by the Commission, Pikeville will furnish to Southern District for retail sale in Floyd County up to 27 million gallons of potable water monthly and at a rate of \$1.69 per 1,000 gallons." (sic)

Applicant Action:

Pikeville has directed to the Commission a copy of its letter dated January 31,2007, addressed to the Board of Commissioners of Southern Water and Sewer District, wherein it acknowledged and agreed to each of the Commission's conditions set out in Ordering Paragraph 1, of the Commission's Order dated January 22, 2007. Further, as stated above, Pikeville has committed to participate with Southern and Mountain Water District in a jointly funded cost of service analysis of wholesale water rates and rate recommendation, which action could have bearing on future volumes and charges for water.

"e. Within 30 days of the date of the transfer, Pikeville shall refund all customer deposits that Sandy Valley District presently holds for customers located in Pike County and shall pay accrued interest on those customer deposits. Within 15 days of this action, Pikeville shall advise the Commission in writing that the required refunds have been made."

Applicant Action:

Pikeville began mailing reimbursement checks May 31, 2007 and will complete doing so by June 6, 2007 to the approximate 1300 former Sandy Valley customers located in Pike County who had paid meter deposits. The total meter deposit liability carried by Sandy Valley for the Pike County portion of its service area as of May 5, 2007 was \$39.566.23, while the total cash in the Sandy Valley customer deposit account was \$9,306.89, which amount was transferred to Pikeville on May 30, 2007.

"f. Within 30 days of the date of the transfer, Southern District shall pay accrued interest on all customer deposits that Sandy Valley District presently holds for customers located in Floyd County. Within 15 days of this action, Southern District shall advise the Commission in writing that the required interest payments have been made."

Applicant Action:

Sandy Valley's total customer deposit liability for customers located in Floyd County as of May 7, 2007 was \$26,588.40; actual cash in the Sandy Valley customer deposit account for customers in Floyd County was \$6,204, which amount was transferred to Southern on May 30, 2007. Southern will make full and timely reimbursement of interest to these customers not later than June 30, 2007.

"g. Southern District and Pikeville shall each establish an office in the area that Sandy Valley District presently serves to receive customer payments, answer customer questions, resolve disputes and negotiate partial payment plans or shall designate a representative in the area who has such office and is authorized to perform such actions.

Applicant Action:

To better assure ease of transition for former Sandy Valley customers, Pikeville and Southern have agreed to rent and jointly staff the existing office space used by Sandy Valley through June 30, 2007. Subsequently, both Southern and Pikeville have jointly secured services of an existing business enterprise, located in a former branch banking facility at Harold, Kentucky. This site is approximately one (1) mile south of Betsy Layne, Kentucky on U.S. 23. The enterprise, Home Satellite Services / Direct TV, staffs the location eight hours daily, Monday-Friday, with two clerks who will be trained in customer service issues relating to water service, such as billing inquiries and payment, as well as new customer applications, compliant filing, and general communication regarding the respective utility services of both Pikeville and Southern. The facility has ample customer parking for access to lobby services as well two drive through lanes for customer convenience. Initial service agreement with the enterprise extends for six (6) months, with an option to extend indefinitely.

On June 8, 2007 letters will be mailed to all former Sandy Valley customers by either Southern or Pikeville, as appropriate, regarding the transfer of system assets, ownership and operation and informing customers of the new, customer convenience center location. Both Applicants consider the location to be an advantage for current customer convenience and service delivery as well as of future benefit, as a strategic location from which to launch the initial public information and 'sign-up' phase of the upcoming sewer line extension project to be constructed in Floyd County.

"2. The proposed transfer shall not proceed unless, within 20 days of the date of this Order, written acknowledgements on behalf of Southern District and Pikeville by each entity's chief executive officer accepting and agreeing to be bound by the conditions set forth in Ordering Paragraph 1 are filed with the Commission."

Applicant Action:

Pikeville directed a letter executed by Mayor Frank Justice to the Commission on Wednesday, January 31, 2007 conforming to the directive contained in Paragraph 2, of the Commission Order dated January 22, 2007. (Exhibit 2, previously submitted)

Southern directed a letter executed by Chair Hubert Halbert to the Commission on Friday, February 2, 2007, also conforming to the Commission's order, as above.

"3. Southern District is authorized to assume 43 percent of the outstanding amount of Sandy Valley District's obligations, as of the date of the transfer, to Rural Development and the U.S. Economic Development Administration, but shall not assume total obligations exceeding \$615,041."

Applicant Action:

Southern's total Sandy Valley debt assumption, including both its share of the Rural Development loan in the amount of \$589,573 and its share of the Economic Development Administration loan in the amount of \$5,709.97, is \$595,262.98. (See Exhibit 3)

"4. Southern shall use the following journal entry (with account balances updated through the date of the transfer) to record the acquisition:

Applicant Action:

Southern has directed its accountant to make the appropriate journal entries provided by the Commission, updated to the date of transfer to record the acquisition of Sandy Valley assets and liabilities and to submit a report illustrating such action by June 29, 2007. A copy of this report will be directed to the Commission at that time.

"5. Within 10 days of completion of the proposed transfer of assets to Southern District, Sandy Valley District and Southern District shall notify the Commission in writing of the completion of the transfer of assets."

Applicant Action:

This document and its transmittal correspondence directed to the attention of Commission Executive Director, Ms. Beth O'Donnell, is provided in response to this element of the subject Order.

"6. Within 10 days of completion of the proposed transfer of assets to Pikeville, Sandy Valley District and Pikeville shall notify the Commission in writing of the completion of the transfer of assets."

Applicant Action:

Sandy Valley executed quit claim deeds and bills of sale to Southern and Pikeville for all assets and liabilities associated with facilities located in Floyd County and Pike County, respectively, effective May 30, 2007. These documents were reviewed by Southern and Pikeville prior to the RD bond closing and prior to making final payment to EDA and subsequently filed in the appropriate County Clerk's office. (See Exhibit 6)

This document and its transmittal correspondence directed to the attention of Commission Executive Director, Ms. Beth O'Donnell, is provided in response to this element of the subject Order.

"7. Within 60 days of the date of this Order, Sandy Valley District shall submit to the Commission a financial and statistical report for calendar years 2005 and 2006."

Applicant Action:

Pikeville retained the services of a local accounting firm to work with current staff of Sandy Valley to assemble the required information. Reports relating to Sandy Valley for the designated years, 2005 and 2006 were brought current through February 2007. It was originally intended by the Applicants to submit these reports together with this summary. In that a more timely completion of all actions relating to the implementation of the Commission's Order, referenced above, was not possible and lest more time ensue, these reports were forwarded to the Commission on May 11, 2007.

"8. Sandy Valley District shall submit to the Commission a financial and statistical report for the period in calendar year 2007 that it owned and operated the system."

Applicant Action:

As cited in Paragraph 7, immediately above, the accounting firm of Wallen & Cornett CPAs, Pikeville, retained by the City of Pikeville, is now accessing the required information with which to complete the report requested by the Commission on Sandy Valley for the period through May 30, 2007. This report will be completed by June 30, 2007 and a copy will be directed to the Commission, under separate cover.

"9. Within 10 days of the completion of the proposed transfer, Southern District shall file with the Commission the journal entry that it proposes to record the acquisition. The acquisition shall be recorded in accordance with the Uniform System of Accounts for Class A/B Water Districts and Associations."

- Sandy Valley Water District hereby requests that the Rural Utilities Service authorize and effect the assignment of its existing unpaid indebtedness associated with its water distribution system and related appurtenances located in Floyd and Pike Counties Kentucky, being a total sum in the outstanding capital amount \$1,405,133 (\$ 1,308,965 and \$ 96,168) to the City of Pikeville and the Southern Water and Sewer District as set out herein below; and
- 2. The City of Pikeville hereby requests the Rural Utilities Service to approve and effect its assumption of 57% or \$ 800,926 of the total debt amount cited in Paragraph 1, above, so that it may own and operate the that portion of the subject water distribution facilities located in Pike County, Kentucky in its name and retire that portion of the indebtedness according to the existing repayment schedule; and,
- 3. The Southern Water and Sewer District hereby requests the Rural Utilities Service to approve and effect its assumption of 43% or \$ 604,207 of the total debt amount cited in Paragraph 1, above, so that it may own and operate that portion of the subject water distribution facilities located in Floyd County, Kentucky, in its name and retire that portion of the indebtedness according to the existing repayment schedule; and
- 4. The Parties make this request by action of their governing bodies and have authorized their respective representative to so attest by signature below:




