O R D E R

Brandenburg Telecom, LLC ("Brandenburg Telecom") filed a complaint against Global Crossing Telecommunications, Inc. ("Global Crossing"). The complaint asserted that Global Crossing refused to pay Brandenburg Telecom for access services provided to Global Crossing by Brandenburg Telecom. Brandenburg Telecom alleged that Global Crossing refused to pay access service invoices for May 2006, in addition to refusing to pay for total access services and dedicated trunking charges also incurred in May 2006. The Commission, by Order, required Global Crossing to satisfy or answer the complaint.

Global Crossing filed a motion to dismiss the complaint, and Brandenburg Telecom filed a response to the motion.

Thereafter, by letter, Brandenburg Telecom notified the Commission that Global Crossing agreed to pay all amounts which are the subject of this complaint.

Brandenburg Telecom has subsequently notified the Commission, by letter, that it has formally withdrawn this complaint.

The Commission HEREBY ORDERS that:

1. Brandenburg Telecom's request to withdraw this complaint be granted.
2. This matter is removed from the Commission's docket.
